## A Message from our Chairman & Manager

We have had another busy year with changes in staff, Board leadership, programs and the uncertainty of the State Budget. During our reorganization meeting in January, Travis Sherman was sworn in as Director after serving many years as an associate, replacing longtime director Dan Wolf. Leroy Walker joined us for the year, but decided to step away, along with Dr Penny Grove who served 3 years. We look forward to welcoming new commissioner/director, Susan Byrnes and associates Rochelle Black, Dan Innerst and Dan Paulus in 2016.

We said goodbye and good luck in retirement to Lowell Luft after 12 years working with our Ag Team. We will all miss Lowell's no nonsense approach to getting the job done, no matter what the job might be. Soon after Lowell retired, we welcomed two excellent new staff members to the District Team – Garrett Miller with the Erosion Control Team and Grant Deller with the Ag team. They have much to learn but have blended in well and are quick studies in their respective roles.

The new Exelon Habitat Improvement Program saw several projects under construction in 2015 as did the new Low Volume Roads component of the Dirt Gravel and Low Volume Roads program. Until the enabling legislation changes, York stands to receive a significant amount of funding for these programs that will help improve our roads, stretch municipal road budgets and protect water quality.

We were pleased to award the first Paul Wilson Conservation Award scholarship to a 2015 Senior High Envirothon participant. We're certain Paul would be very proud of this effort to help support our next generation of conservation leaders.

We initiated a Facebook Page for the District to help with district program promotions hoping to participate in the social media revolution, at least a little. It complements the District's web page well.

The Chesapeake Bay again has risen to the forefront of agency agendas all around the state and region, with Pennsylvania feeling the first imacts of falling short of the established milestones, in the form of backstop measures now being implemented by EPA. This issue will likely reshape our Ag programs, and perhaps most everything we do in the coming months. Fortunately, we have taken big strides in York County to begin to address stormwater in a more sustainable, coordinated approach with great leadership from the York County Planning Commission.

It was a very busy year for construction site development and earthmoving, as activity returned to pre-recession levels. With the State & Federal Erosion Control and Permit program growing in complexity, our staff struggled to maintain the level of field presence we set in our goals. Fortunately, most of our rainfall this past year fell in manageable amounts, with a few exceptions in isolated areas of the County. Fortunately, the vast majority of sites found to have issues were brought into compliance voluntarily. We do have several significant highway projects in sensitive areas that will require our attention for some years to come. And we will have a significant pipeline project to oversee in the Northern part of the County, so 2016 looks to be another challenging year for the E&S team. Thankfully, we have an excellent team who are up to the challenge.

The York County Commissioners continue to be strong advocates of the District. Without their continued support, we would not be able to meet the opportunities that seem to come in waves. Our building committee continues to work with the County as we labor to determine how we can make our goal of an Ag Center a reality for York County. Stay tuned for more on that, right Jack?

We again are grateful for the continued excellent leadership provided by our Directors and Associates, as well as the excellent work put forth by the District employees and the many cooperating agencies we so depend on. Thank you all for another great year of conservation service to help make York County better than we found it, for present and future generations.

### Capital Resource Conservation and Development Area Council (RC&D)

The Capital RC&D Area Council builds partnerships of concerned citizens, businesses, agencies and organizations to work together improving the quality of life within the seven county area: Adams, Cumberland, Dauphin, Franklin, Lancaster, Lebanon and York. The District has three representatives serving on the RC&D board: Julie Flinchbaugh represents the District Board of Directors, Nedette Otterbein of the Horn Farm Center for Agricultural Education, represents the County Commissioners, and Patricia Devlin, Dillsburg, is a member-at-large. Patricia Devlin agreed to reappointment to a 3-year term as our member-at-large. Capital RC&D Council consists of volunteer representatives from local government, conservation districts, business, development organizations, nonprofit groups

and individuals. This council of 21 volunteers initiates and directs program activities. Projects are selected by evaluating local needs that promote conservation of our natural and community resources. The council provides the selected projects with necessary tools, such as technical expertise and assistance in locating funds. Resource Conservation & Development projects can focus on land conservation, water management, community improvements, alternative energy applications, recreation and tourism, forestry resources, recovery/recycling, rural economic development, as well as public information and education. We contracted with Capital RC&D to assist with the tillage survey in York County.

#### GOAL: To Build The York County Agriculture and Natural Resource Service Center

The mission of the York County Conservation District is to protect and improve the natural resources of York County. To fully realize this mission, the Conservation District is planning to build the York County Agriculture and Natural Resource Service Center at an estimated cost of \$9,000,000. Constructed with numerous green technologies, this building will house offices and meeting space for the Conservation District as well as our key cooperating agencies, and thus serve as a headquarters for agriculture and natural resource conservation in York County. Citizens from all walks of life-farmers, developers, onservationists, municipal officials, students, etc. - will vist the Center to get technical assistance, apply for programs, attend workshops, investigate green building options, or partake in the numerous other services offered there.

## Ag Resources

2015 Agricultural Conservation Program Accomplishments

- Wrote conservation and grazing plans on 26 tracts 1,204 acres.
- Implemented conservation plans and practices on 781 acres.
- Installed 23 Best Management Practices (BMPs) to control erosion on 20 acres & prevented 116 tons of sediment loss.
- Used cost share from CBP Special Project grant to assist the District with hiring an intern to help update the ACRE database and educational outreach visits \$ 1,539
- Developed plans and implemented incentive contracts using USDA-NRCS funding. Installed 17 BMPs spending \$189,385 of incentive funds on 5 existing contracts.
- Provided educational opportunities to farmers, cooperators and the general public about the District ag program and manure management planning. Staff took displays and handouts to the following three events: the York County Corn and Soybean Clinic, the Ag Recognition banquet and Ag Night at the Revolution sponsored by the Ag Business Council. Gave a presentation about Ag Regulations and Landowner responsibility at meeting hosted by the Red Lion Municipal Authority.
- Published articles for the District newsletter about Stream bank Fencing, Manure Management Plans and Manure Spreading and Winter Application.





- Provided support for the REAP program administered by the PA Dept. of Agriculture. Performed 2 plan verifications for program applicants.
- Continued to support the agreement with DEP and the York County Solid Waste and Refuse Authority to monitor the Land Application of Biosolids program. Assisted with the monitoring of farms for conser vation compliance and reviewed conservation plans for permitted farms.
- Continued Education and Outreach program to inform farmers and landowners of the changes to Chapter 102 (E&S) and Chapter 91(MMM). Completed the fourth round of 250 visits by June 30, 2015 and started on next 250.
- Assisted the District Erosion and Sediment program staff with implementing the Agriculture Complaint Handling Guidelines. This includes Ag E&S and Manure complaints site visits and plan reviews.
- Partnered with NRCS on a Contributory Agreement to provide engineering design and construction in spection assistance on federally funded projects. The District completed the original agreement and earned \$24,710 and also signed a new agreement for an additional \$30,000 from which we earned \$6,018.
- Implemented conservation practices with funding provided by the York County Community Foundation. One cooperator installed grass waterways and mulching using \$8,925.

### Ag Conservation Program Accomplishments, con't

- Partnered with NRCS on a new Contributory Agreement to provide conservation planning assistance. Grant total is \$55,000. Funding will be used to support new ag positon in 2016.
- Ag staff changes Lowell Luft retired in March and Grant Deller was hired in April.
- Partnered with the York County Ag Business Council's Farm Tour event in October. The District had a tabletop display and handouts and also developed a self-guided tour of conservation practices for attendees at the Alta Vista Dairy Farm.



### 2015 Nutrient Management Act Program

The York County Conservation District is delegated by the State Conservation Commission to oversee Pennsylvania's Nutrient Management Act (Act 38) in York County.

Active plans on file:

- Twenty-four current nutrient management plans are on file for Concentrated Animal Operations (CAOs) in York County.
- Eleven of these operations are also regulated as Concentrated Animal Feeding Operations (CAFOs).
- One plan is for a Concentrated Animal Feeding Operation (CAFOs) only (not a CAO).
- Five plans are for Volunteer Animal Operations (VAOs). These operations are not required by Act 38 regulations to have an approved plan, but voluntarily choose to do so.

Annual Status Reviews:

• Under Act 38 regulations all CAOs are required to have an annual review conducted to determine if they are in compliance with the regulations. All CAOs received status reviews in 2015.

### Plan Reviews and Approvals:

In 2015, 18 nutrient management plans were received for review by the District.

- 10 plans were updates for existing CAO or CAFO plans.
- 1 plan was for a new CAO/CAFO.
- 1 plan was for a new VAO.
- 1 plan was for an existing VAO.
- 13 plans were approved by the Board of Directors in 2015 (3 were under review from the previous year). 5 plans are still under review.
- 1 plan was disapproved but later approved following another review
- 1 plan was approved and later rescinded and subsequently approved by the State Conservation Commission after further review.

Nutrient Management Act Program, cont.

Educational Activities:

- In 2015 educational activities concerning nutrient management and manure management included displays at the Ag Night at the Rev's baseball game, the York County Corn and Soybean Clinic, the Ag Recognition Banquet and the York County Farm Tour.
- A one hour overview of the regulations for manure management and conservation planning was given to approximately 8 people at the York County Corn and Soybean Clinic breakout session. A second break out session was held for 45 minutes in the afternoon helping 6 people write their own plans.
- A Soil Quality and Conservation Forum was held at the Airville Fire Hall for about 40 people.
- Ag staff also assisted in developing a manure management plan for a local farmer which he needed for a REAP application.
- In order to maintain certification and keep informed on current nutrient management issues, Ag staff members attended trainings throughout the year.
- Staff worked with two individually certified nutrient management specialists (certified by PA to write plans for their animal operations) assisting them in acquiring certification update credits.
- As part of the Manure Management delegated responsibilities the District partnered with John Rowehl, PSU Cooperative Extension, to present a Manure Management Plan writing session for 15 attendees.

### 2015 was the 30th Anniversary of the York County Envirothon!

Nearly 1,000 students on 166 teams participated in this year's events. Here are the numbers:

- <u>Senior High</u> 20 teams & coaches, 120 students, 5 testing stations, 12 school districts and 31 volun teers.
- <u>Middle School</u> 30 teams & coaches, 180 students, 4 testing stations, one non-testing station, 13 school districts and 35 volunteers.
- <u>5th & 6th Grades</u> 46 teams & coaches, 276 students, 4 testing stations, one non-testing stations, 13 school districts and 37 volunteers.
- <u>3rd & 4th Grades</u> 70 teams & coaches, 350 students, 3 testing stations, a scavenger hunt, 2 nontesting stations, 16 school districts and 42 volunteers.

Our Envirothon Committee had 29 members, 16 of whom were Station Leaders who created & edited study resources and taught & tested students on Aquatics, Environmental Current Issues, Forestry, Soils and Wildlife. The Senior High Current Issue was Urban Forestry and the Current Issue at the 5th thru 8th Grades levels was Biodiversity and Invasive Species. The Station Leaders presented a total of 106 study sessions for all grade levels in all topics during the study sessions at Nixon Park and surrounding sites.

Our Annual Seedling Sale




The year 2015 marked the 41st year for our annual Seedling Sale. Sales this year totaled \$30,121, with a profit of \$12,625 from the 546 orders. The profit will be used for the District's educational programs as well as discretionary expenses. Again this year, over 20,000 seedlings were sold, including favorites such as the white pine and Colorado blue spruce varieties. We also offered a coupon on our website and in our newsletter redeemable for a free bareroot white pine seedling.

An estimated 800 seedlings were donated to the York County Parks Department for planting on the hillside behind the boat rental area at Lake Redman, which had previously been overgrown with invasive species.







## Erosion & Sediment Control

### PROGRAM ACCOMPLISHMENTS for Pollution Control and National Pollution Discharge Elimination System (NPDES)

2015 was a busy year for the E&S program. The E&S Team comprised of Eric Jordan, Robert Fetter, Tiffany Crum, Karen Ward, Garrett Miller and two administrative staff, Whitney Leland and Robin Sharp continued to provide an active field presence to ensure that erosion and sediment (E&S) control and post-construction stormwater management (PCSM) plans are fully implemented on the ground. Our newest engineering technician, Garrett Miller, joined our team in March of 2015. The District continued to administer the E&S/NPDES program at Level III of the PA Department of Environmental Protection (DEP) delegation agreement. Level III includes reviewing E&S plans, processing NPDES permits, investigating complaints, conducting educational workshops, site inspections, and enforcement actions at the local level.



### The following is a summary of the E&S team's activities for 2015:

- Conducted 912 site inspections, pre-construction meetings, site meetings, plan review site visits & status checks.
- Investigated 163 new complaints.

- Reviewed 257 new and 197 revised plans.
- Processed 125 General NPDES permits.
- Issued 89 New General NPDES permits.
- Renewed 1 Individual NPDES permits
- Processed 2 Individual NPDES permits.
- Processed 5 Erosion and Sediment Control General Permits for Oil & Gas transmission lines.
- Issued 4 Erosion and Sediment Control General Permits for Oil & Gas transmission lines.
- Staff continued to foster a working relationship with the County's 72 municipalities.

### Erosion & Sediment Control, cont.

- Rob assisted Gary Peacock, Watershed Specialist, with education and administration of the Dirt & Gravel Low Volume Road program.
- Eric, Karen and Garrett presented a 2-hour long E&S PowerPoint presentation to 16 attendees at RGS & Associates' office in Lancaster.
- Eric assisted Ag staff with presenting at the District's Soil Quality & Ag Conservation Forum at the Airville Fire Hall in June. E&S technicians also attended. There were 40 attendees.
- E&S staff conducted a successful NPDES Permitting Workshop at Wyndridge Farms in York Township. There were 96 plan preparers and developers in attendance.

## Watershed Programs

York County's water resources and watershed program continues to be a high priority for the Conservation District.



The York County Conservation District's annual work plan for 2015 identified four (4) priority watershed activity areas, and they were Special Projects, Stormwater Management, Water Quality Management, and Water Resources Management. In each of the four focus areas watershed activity included education and outreach, financial assistance (funding), technical assistance (watershed), training, and other District programs.

### Water Resources Management

- Implemented the Floodplain Monitoring Program and assisted municipalities (2) in the National Flood Insurance Program and landowners (1) with floodplain assessments, time and resources allowed.
- Pursued dedicated or special funding for stream restoration and protection projects, including Common wealth Finance Authority Watershed Grants, Exelon Habitat Improvement, Growing Greener Program, and Regional Conservation Partnership Program.
- Continued supporting York County's Drought Task Force, as necessary.
- Provided technical assistance to the Red Lion Municipal Authority's Source Water Protection Plan implementation.
- Assisted local municipalities (72) and watershed groups (25) with Rivers Conservation Plan (4) implementation efforts, as requested.



### Stormwater Management


- Assisted PennDOT, York County, MS4 Municipalities (43), individual municipalities (8), and citizens (5) in reviewing stormwater problems, recommending BMP solutions, and referred complaints (2) to appropriate local or state agencies.
- Assisted York County Planning Commission, Watershed Alliance of York (WAY) and other groups with stormwater management, watershed planning projects, MS4 program, and County-wide Chesapeake Bay Pollutant Reduction Plan.
- Referenced DEP's Stormwater BMP Manual in two (2) training sessions and complaint (5) handling.
- Coordinated with York County Planning Commission to hold 3 meetings of the York County MS4 Stormwater Collaborative to discuss ways to better work together in post-construction stormwater management process.
- Supported York County with its MS4 permit implementation by serving on the MS4 Committee and provided appropriate report information.
- Participated in three (3) public meetings for the York County Stormwater Authority Feasibility Study.

### Special Projects

- Served as sponsor for projects to improve and protect water resources.
- Served on the York-Adams Regional Smart Growth Coalition Board of Directors.
- Implemented Large Woody Debris Program, using York Haven resources, completing 2 projects for \$3,670 total.
- Promoted use of rain barrels and rain gardens as effective stormwater BMPs at two (2) workshops.
- Continued developing a database of riparian stream buffers for York County.
- Supported York County's Total Maximum Daily Load Work Group and the York County Coalition for Clean Water, and the Watershed Implantation Plan.
- Implemented new Exelon Habitat Improvement Project (HIP) funding program. Received funding requests for 22 projects, approved 7, committing \$217, 578 total. Restored 400 feet of stream, riparian forested buffer and floodplain wetlands

### Water Quality Mgmt. cont.

- Planned to co-sponsor a 2016 workshop on soils and septic systems for municipal officials and others, with appropriate state and local agencies. Provided on-lot disposal systems (OLDS) resource publication/ presentation to local municipal officials, builders, homeowners, and others as requested.
- Educated homeowners (>50,000) on their contributions and impacts to water quality.
- Assisted landowners (23) with Chapter 105 Regulations for stream encroachments and wetlands protection and referred them to the appropriate state or federal agency.
- Administered Dirt and Gravel (DGR) and Low Volume Road (LVR) Programs. Promoted both programs in the District's newsletter, online and through direct contact. Sponsored four (4) grant application rounds, generating potential project applications (22) from local road maintenance entities (8), resulting in environmentally sensitive road maintenance projects (7 LVR; 6 DGR). Total project funding committed for DGR and LVR projects was \$160, 502 and \$394,632, respectively. Encouraged all municipalities to attend the DGR training for project eligibility. Chaired the DGR/LVR Quality Assurance Board and appoint members as necessary. Hosted one (1) training workshop.
- Assisted landowners (3) with pond-related concerns and issues by referring them to the Pond Management Guide, PSU Coop Extension's Water Resources web site, and other resources.
- Advised and assisted existing watershed associations (25) as requested. Actively assisted the Codorus Creek Watershed Association's Board of Directors with implementation and management of their Growing Greener and 319 NPS projects (3).
- Continued supporting the WAY, via the approved MOU.
- Continue implementing the Headwaters Environmental Legacy Program (HELP) encouraging landowners (28) with headwater streams on their property to be good stream stewards by providing financial incentives (Exelon HIP funding) and technical assistance.



### Other

- Worked closely with the District's Education/Communications Coordinator writing three (3) educational articles for the Conservation Horizon's newsletter and website offerings.
- Supported the District's York County Envirothons at the elementary, intermediate, middle, and high school levels educating 1,000 school students in grades 3-12.
- Assisted District with its annual tree seedling sale at Rocky Ridge County Park.

"It shall be the mission of the York County Agricultural Land Preservation Board to protect York County's agricultural resources through the preservation of economically viable farms and the creation and maintenance of stable agricultural communities."

- YCALPB welcomed John Eaton representing Citizen-At-Large replacing outgoing Nelson Roth and welcomed J. Kenetha Hansen, Citizen-At-Large replacing Dennis Martin.
- The York County Agricultural Land Preservation Board reviewed and approved changes to the County of York Conservation Easement Donation/Bargain Sale Program.
- York County continues to rank 3rd in Pennsylvania for acres of farmland preserved.
- Since program establishment in 1989, the York County Agricultural Land Preservation Board has preserved 273 farms, covering 40,988 acres of productive farmland.
- Board and staff received a total 49 easement applications on 4,628 acres offered for farmland preservation and ranked 28 qualifying applications, covering 2,305 acres. Additional program inquiries were received from 26 citizens representing 1,977 acres.
- The York County Agricultural Land Preservation Board selected 6 farms for preservation, covering a total 516 acres.
- Staff conducted annual inspection visits on 247 farms, covering 37,836 acres of productive farmland.
- YCALPB staff co-inspected three Heritage Conservancy easements located in York County on 393 acres with Heritage Monitoring staff.
- YCALPB staff conducted 25 Municipal Agricultural Security Area reviews in cooperation with the YCPC and Municipal Officials, involving 777 parcels involving 40,624 acres.
- YCALPB staff, in cooperation with York County Planning Commission, updated the GIS layers involving conservation easements and agricultural security areas.
- The York County Agricultural Land Preservation Program conservation requirements contributed to York County's conservation planning efforts on 19 tracts, covering 1,903 acres.
- The York Board of Commissioners certified easement funds totaling \$164,875 for farmland preservation, and received \$1,117,557 in match ing State funds for 2015 preservation efforts.
- The YCALP Office, with Conservation Partners, hosted a November 19, 2015 Public Meeting on "Protecting Your Farmland " with 32 in atten dance.
- The YCALPB provides citizens with agency and program information via the County of York's web site www.yorkcountypa.gov under the Property & Taxes banner with total visitors numbering 1,065 in 2015.

## U.S.D.A York Field Team Report

- NRCS, District & Ag Preserve employees wrote or updated 116 plans on 5,603 acres of land in York County for FY 2015.
- The York Field Team implemented conservation practices that benefited water and soil quality on approximately 5100 acres.
- Obligated over \$135,000 in 7 new contracts through the Environmental Quality Incentive Program (EQIP) in 2015.
- Certified 103 contracted items accounting for 31 different practices in 2015. Total incentive money paid to the Farm Bill Program participants totaled over \$362,000.
- Enrolled or reenrolled 31 CREP contracts totaling 244.8 acres.
- Reenrolled 10 expiring and enrolled 3 new Conservation Stewardship Program (CSP) contracts totaling over 7900 acres.
- Finalized two easements under the Wetland Reserve Enhancement (WRE) Program totaling over 33 acres. Completed the first WRE restoration in York county creating or enhancing 1.8 acres of wetlands.
- Soil Conservationist Wendy Zwally retired in July after 35 years with NRCS and 22 years working in York County.

## U.S.D.A. Farm Service Agency FSA

• USDA's York Farm Service Agency (FSA) works to increase economic opportunity and improve the quality of life for rural Americans. Some of the agency's efforts include facilitating income support, disaster assistance and conservation programs, providing operating loans for the procurement of farm equipment, seed and fertilizer, as well as offering ownership loans to help new and veteran producers purchase a farm.

• York County FSA has nearly 3700 producers associated with 4,973 farms in York County. Last year was an exciting and busy year for us as we worked to implement the Agricultural Act of 2014 (2014 Farm Bill).

• Over 400 York County producers on approximately 2800 farms are eligible for the Price Loss Coverage (PLC) and Agricultural Risk Coverage (ARC) programs. These replaced the Direct and Counter-Cyclical Program (DCP) and help protect producers when there are either price or revenue losses. In October we issued over \$1,775,000 in payments to York County farmers for crop year 2014 losses.

• We still offer our Conservation Reserve Enhancement Program (CREP) contracts and have 245 contracts for CRP and CREP, consisting of over 2400 acres and receiving annual rental payments in excess of \$420,000. Additionally, we provided thousands in cost-share and incentive payments for the installation of long term resource conserving covers, much of which was matched by Pennsylvania's Department of Agriculture.

### U.S.D.A. con't

• Our Noninsured Crop Disaster Assistance Program (NAP) program remains an important tool for producers of noninsurable crops to protect against natural disasters. The 2014 Farm Bill authorized additional coverage levels ranging from 50 to 65 percent of production, in 5 percent increments, at 100 percent of the average market price.

• York FSA also assisted local grape growers with our Tree Assistance Program (TAP), which provides financial assistance to eligible orchardists and nursery tree growers to replant or rehabilitate eligible trees, bushes, and vines lost by natural disasters. We are able to help cost-share replanting of lost vines after the 2015 spring cold snap killed off vines for several of our growers.

• Our Farm Loan staff provides Direct and Guaranteed Farm Ownership loans and Operating loans to producers in York County who may have difficulty receiving credit through traditional lenders. For 2015, FSA made 10 loans to York County producers totaling nearly \$694,000.

• York producers who participated in our 2015 Marketing Assistance Loans (MAL) have received over \$2.1 million dollars to allow for more flexibility on when to market their crops. Producers can also take advantage of our many other programs; Margin Protection Program for Dairy (MPP-Dairy), Farm Storage Facility Loans (FSFL), Livestock Indemnity Program (LIP), and the Emergency Assistance for Livestock, Honeybees, and Farm-Raised Fish (ELAP) to name a few.


